TN will repent if it votes for NDA, says Kejriwal in Chennai

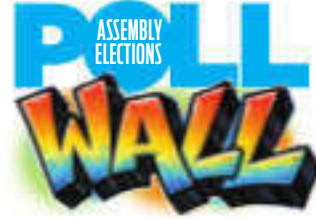

NATIONAL convener of the AAP Arvind Kejriwal on Monday said the people of Tamil Nadu would "repent" if they voted NDA in the state in the April 23 polls, saying the state would meet the same fate as Delhi where the BJP "stopped all the good work" of AAP.

Addressing a massive gathering at a roadshow along with Tamil Nadu Chief Minister M K Stalin here, in support of the DMK-led Secular Progressive Alliance candidates, the former CM of Delhi said Tamil Nadu doesn't want the BJP.

Kejriwal, who addressed from atop a campaign vehicle with Stalin standing beside him, pointed at the huge crowd on either side of the road and said, "The AIADMK has done the biggest crime of bringing the BJP to Tamil Nadu." "A year ago, the people made a mistake by voting for the BJP and now all the good work that we have done in Delhi, has been stopped by the BJP. The schools we started in Delhi, the clinics, free medicine and treatment in hospitals, free electricity and free water have all been stopped by the BJP," he said.

Whether the people voted for the BJP or the AIADMK or NDA made no difference, because all the good work that Stalin has started in Tamil Nadu will be stopped if the NDA won the election, "and you will repent," the top Aam Aadmi Party leader cautioned. "So, I request vote for Stalin saab (sir), and the DMK if you want to sustain the good work. He (Stalin) has done a lot of developmental work. This development should continue. He is one voice and a strong voice, too, against PM Modi in the Centre," he said. Stalin was fighting not only for Tamil Nadu but also for the country. "He defeated the delimitation bill which would have completely destroyed our democracy and he stood against Modi and fought for the people of Tamil Nadu," Kejriwal said.

Modi went to Israel complying with Trump's diktat: Rahul

CONGRESS leader Rahul Gandhi on Monday alleged that Prime Minister Narendra Modi visited Israel before the war broke out in Iran, complying with what he was told by US President Donald Trump.

Addressing an election rally here, targeting the BJP, Gandhi reiterated his allegation that "PM Modi will jump if Trump asks him to do so". Further, he alleged that before the war in Iran, suddenly Modi was told to go to Israel, and he took a plane, went there and came back. The reason for such behaviour was simple, "Epstein files and Adani," he alleged.

The Union government had rejected references to PM Modi in the latest Jeffrey Epstein case files, describing it as "little more than trashy ruminations by a convicted criminal that deserves to be dismissed with the utmost contempt". Gandhi alleged that US President Donald Trump openly says that PM Modi picks up the phone when he calls and addresses him as, sir and added: "Imagine the Prime Minister of India calling US President Donald Trump, sir." Similarly, PM Modi expects the chief minister of Tamil Nadu to be submissive to him and address him as "sir". However, CM Stalin will never address Modi as sir. So PM Modi wishes to have an AIADMK CM in Tamil Nadu so that he would pick up the phone and say, "Yes sir, what can I do for you?" The BJP wants to have a government in Tamil Nadu that they can fully control, a chief minister who does exactly what they say.

Rahul said, "No matter what dream they have, they will never ever control people or the government of Tamil Nadu, and we will never allow the BJP to have a government they can control in the state."

Firecracker unit blast: Toll hits 25, HC seeks TN's reply on relief

ON Sunday evening, the Government Medical College Hospital (GMCH) in Virudhunagar witnessed a steady stream of ambulances arriving at the mortuary, each carrying the charred remains of workers killed in the Kattanarpatti cracker unit explosion.

Family members had already gathered at the hospital. As ambulances arrived, many peered through the windows, attempting to identify their loved ones even before the doors were opened. However, most bodies were burnt beyond recognition, leaving families distraught. "Athu yarunu therlayae (can't recognise the person)," lamented the daughter of one of the victims, breaking down. The bodies were moved into the mortuary one after another, and relatives were called in individually for identification.

The Madurai Bench of Madras High Court on Monday orally instructed the government counsels to get instructions from state authorities on the compensation proposed to be paid to the victims of the cracker unit blast in Kattanarpatti village in Virudhunagar on Sunday. A bench of justices N Sathish Kumar and M Jothiraman raised the question following a request made by a counsel, R Karunanidhi, asking the court to take suo motu cognisance of the incident.

ODISHA SIR 9.8 lakh voters removed, wrongful deletions alleged

AHEAD of the crucial Special Intensive Revision (SIR) of electoral rolls in Odisha, a whopping 9.8 lakh names have been deleted during the ongoing mapping exercise, drawing serious allegation of wrongful removals. The development has also led the chief electoral officer (CEO), Odisha, RS Gopalan, to put on hold the scrutiny of around two lakh Form-7 applications received after April 2, 2026, which seek deletion or raise objections to entries in the rolls.

The 9.8 lakh deletions have

been carried out by electoral registration officers since the commencement of the mapping process. With Odisha having about 3.40 crore electors as per the 2025 summary revision, including 1.72 crore men, 1.68 crore women and 3,434 transgender people, the deletions account for roughly 2.88% of the electorate.

The exercise has triggered complaints of wrongful removal of voters from the rolls. In a recent letter to EROs, additional chief electoral officer Sushanta Kumar Mishra underlined that a substantial number of complaints have been received against wrongful deletions.

Police flag ₹20-cr scam linked to Sabarimala

KOCHI: Kerala police flagged serious irregularities linked to the 'neyy thenga' ritual at the Sabarimala temple, with contractors suspected of illegally diverting the ghee-filled coconuts, meant to be consigned to the sacred 'aazhi' (fire pit), to private godowns. The 'illicit trade' is estimated to have generated up to Rs 50 lakh a day, potentially touching Rs 20 crore during the last season, despite contracts permitting only the collection of coconuts broken at designated areas on the temple premises. A report of the intelligence wing seeking a detailed investigation has been submitted and the matter has reached officials of the Travancore Devaswom Board, including the Sabarimala special commissioner and the executive magistrate, said a source. A Bengaluru-based company secured the annual contract to collect the coconut offerings for an amount of Rs 7.61 crore, the source said. ENS
