Motorists demand green shade nets at signals to beat heat

AMID the rising summer heat, motorists in Coimbatore have demanded the Coimbatore City Municipal Corporation (CCMC) to install green shade nets at major traffic signals to shield commuters from the harsh sun.

Over the past few years, the installation of green nets at busy junctions has provided much-needed relief to motorists and pedestrians waiting at signals. However, the absence of such measures this year has left many exposed to rising temperatures.

"Afternoon travel has become unbearable. Even waiting for a minute at signals feels exhausting," said R Karthik, a daily commuter from Gandhipuram. Echoing similar concerns, S Maheshwaran, a college student, added, "The green nets

made a real difference. It's a simple step, but it protects thousands of people every day."

Earlier, several councillors had urged the civic body to take proactive measures, including the installation of green nets across key intersections. In previous years, such initiatives were implemented in coordination with NGOs as part of broader summer preparedness efforts.

CCMC Commissioner M Sivaguru Prabhakaran told TNIE, "In previous years, the Revenue and Disaster Management Department issued instructions to undertake precautionary measures ahead of summer. These included setting up free buttermilk and water distribution stalls, as well as installing shades at traffic signals in collaboration with NGOs. However, this year, we have not received any such instructions so far."

Man attacks estranged wife, held in Annur

COIMBATORE: A 33-year-old man was arrested by the rural police after he allegedly attacked his estranged wife with a sickle, inflicting serious injuries on her head and hands.

The suspect, K Soundararajan of Molakalipalayam near Sulur, works at a powerloom in Kaduvettipalayam. He was married to Deepika (28) 10 years ago and the couple has two children, a 9-year-old daughter and a 7-year-old son.

Due to a family dispute, they had been living separately for the past six months. Deepika was residing with her children at AM Colony near Annur.

On Monday, Soundararajan visited his wife's house and got into a heated argument. Enraged, he allegedly attacked Deepika with a sickle, slashing her head and hands. Upon hearing her screams, neighbours reached the spot, forcing the accused to flee. Deepika was immediately rushed to Annur GH for first aid and later shifted to CMCH, Annur police registered a case and arrested Soundararajan. He was produced before the court and remanded in judicial custody. Further investigation is on.

Man kills 72-yr-old after tussle over dumping garbage

A 72-year-old woman was murdered in broad daylight, allegedly by a 47-year-old man following a long-standing dispute over garbage dumping in a shared compound, on Wednesday.

The deceased, Jessy Vincent,

a widow from Kanniyakumari district, was residing alone in Karunya Nagar for the past 26 years. The suspect, Noble Watson Thangadurai from Kanniyakumari, was also living in the same compound.

According to preliminary investigation by Karunya Na-

gar police, frequent quarrels erupted between the victim and the suspect over the issue of dumping garbage in the common area.

On Wednesday morning, a verbal altercation escalated when Jessy allegedly abused Noble's mother, which provoked

him. In a fit of rage, he allegedly took a sickle from his house and struck Jessy on the back of her head. Jessy collapsed and died on the spot.

Karunya Nagar police reached the spot and conducted an investigation, and Noble was arrested. Jessy is survived by two sons and a daughter.

Nagercoil-Coimbatore train to short terminate at Erode

Coimbatore: The Nagercoil-Coimbatore Express train (No.16321), which is scheduled to leave Nagercoil at 08.00 am, will be short-terminated at Erode Junction railway station on May 10 in view of track renewal works at the Uthukuli Railway Yard in the Erode-Tiruppur sector. After completion of the works, the train will run as an Unreserved Special Train from Erode Junction to Coimbatore Junction with the same stoppages of Train No. 16321.

Three injured as car hits two-wheeler in RS Puram

Coimbatore: Three persons sustained injuries after a car allegedly rammed a two-wheeler at TV Samy Road in RS Puram on Tuesday. According to police, V Thangaraj (40), a resident of SITRA Junction was driving his car when he hit a two-wheeler carrying Vishnu (22), Mohammed Adhil (24) and Anuthosh, all from RS Puram. The impact of the collision threw the riders off the vehicle, resulting in serious injuries to all three. They were immediately rushed to a private hospital for treatment. Traffic Investigation Wing West registered a case against the car driver, and an investigation is on.
