 I am directed to refer to the online proposal no. FP/RJ/OTHERS/532057/2025 dated 30/03/2025 on the above-mentioned subject seeking prior approval of the Central Government in accordance with section '2' of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and to say that the proposal has been examined by Regional Office as per rules. After the examination, I am directed to convey the "In-Principle/Stage-I" approval of the Central Government under section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for the Proposal for non-forestry use of 0.85 ha of forest land under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 in favour of M/s KOTA DEVELOPMENT AUTHORITY for Bundi Territorial Division in Forest Division, District KOTA (RAJASTHAN) subject to the fulfillment of the following conditions:

- 1. General Conditions**
- S. No Conditions**
- 1.1** Legal status of the diverted forest land shall remain unchanged
- 1.2** The total forest area utilized for the project shall not exceed 0.85 Ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal
- 1.3** The boundary of the diverted forest land, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, at 20 m apart, each inscribed with its serial number, forward and back bearing/ Geo-coordinate and distance from pillar to pillar.
- 1.4** The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation, at the current wage rate, to the State Forest Department. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years
- 1.5** The State Government shall charge the Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02.2009 in this regard
- 1.6** At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India
- 1.7** All the funds received from the user agency under the project, except the funds realized for regeneration/ demarcation of safety zone, shall be transferred to Ad-hoc CAMPA in the Savings Bank Account pertaining to the State concerned
- 1.8** The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required
- 1.9** The User agency, if required, will undertake comprehensive soil conservation measures in the area being diverted at the project cost in consultation with the State Forest Department. A scheme of the same may be submitted along with the compliance report
- 1.10** No labour camp shall be established on the forest land
- 1.11** The User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas
- 1.12** The forest land shall not be used for any purpose other than that specified in the proposal
- 1.13** The layout plan of the proposal shall not be changed without the prior approval of the Central Government
- 1.14** The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government
- 1.15** No damage to the flora and fauna of the adjoining area shall be caused
- 1.16** Any tree felling shall be done only when it is unavoidable and that to under strict supervision of the State Forest Department
- 1.17** The State Government shall complete settlement of rights, in terms of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted in accordance with the relevant guidelines issued by the MoEF
- 1.18** The user agency in consultation with the State Government shall create and maintain alternate habitat/home for the avifauna, whose nesting trees are to be cleared in this project. Bird's nests artificially made out of eco-friendly material shall be used in the area, including forest area and human settlements, adjoining the forest area being diverted for the project
- 1.19** The User Agency shall submit self-compliance reports to this office as well as to the Nodal Officer of the State
- 1.20** The State Government shall monitor compliance of conditions of Forest Clearance and shall submit in this regard yearly report as on 31st December of every year
- 1.21** Any other condition that the concerned Regional Office of this Ministry/State Govt may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife
- 1.22** The User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project
- 1.23** Grant of working permission to the extant proposal may be considered by the State Government in accordance with the provisions as contained in the MoEF&CC's Guidelines dated 28.08.2015
- 1.24** Compensatory afforestation shall be taken up by the Forest Department over 1.0 ha DFL Survey No. Nil, Village- Dhorela, Range-Dabi, Tehsil-Talera, District-Bundi of Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and mono-culture of any species may be avoided.
- 1.25** The KML file of the forest area to be diverted and CA area shall be uploaded on the e-green watch portal

S. No.	Conditions
3.1	The User Agency shall provide CA in NFL area for compensatory afforestation in lieu of the forest area diverted, if applicable, based on the final outcome in the WP No.1164/2023, which is currently pending before the Hon'ble Supreme Court of India. The State Forest Department shall ensure that an undertaking from the user agency is obtained in this regard.

Transfer of forest land shall not be effected till final approval is granted by the Government in this regard.

Further, it may also be noted that this in-principle approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions within 5 years, the in-principle approval may be revoked by the Central Government.
