CPM slams 'pension disbursal'

EXPRESS NEWS SERVICE @Malappuram THE CPM district secretariat has demanded legal action against those involved in distributing welfare pensions from the UDF election committee office in Pulpetta, alleging violation of norms. District secretariat alleged that the Pulpetta Cooperative Bank, controlled by the Muslim League, summoned pension beneficiaries to the UDF office. The process was reportedly coordinated by bank employee C Akbar and Youth League activist Wahid in the presence of the Pulpetta panchayat president. A video showed beneficiaries waiting in queues outside the office till night.

Daytime ban on multi-axle vehicles on Ghat Road

Strict restrictions in force from 6 am to 8 pm; collector issues order

EXPRESS NEWS SERVICE @Kozhikode IN VIEW OF the intensifying southwest monsoon and the increasing risk of accidents along the ghat section, Kozhikode District Collector and chairperson of the district disaster management authority, M S Madhavikutty, has imposed strict restrictions on the movement of heavy multi-axle vehicles through the Thamarassery Ghat Road on NH 766. The order was issued following a high-level meeting convened to discuss traffic management on the ghat road during the monsoon season. The meeting was chaired by Agriculture Minister T Siddique and attended by MLA C K Kasim, along with the district collectors of Kozhikode and Wayanad. Under the new directive, the restrictions will remain in force daily from 6 am to 8 pm and will continue until the end of the monsoon season or until further orders are issued. Authorities have advised heavy vehicles travelling to and from Wayanad to use alternative routes, including the Kuttia and Nadukani ghat roads. The collector has directed the Kozhikode rural police to strictly enforce the order, which

has been issued under the provisions of the Disaster Management Act. According to the notification, all trucks, lorries, tankers, trailers, container carriers, and other heavy vehicles will not be permitted to pass through the Thamarassery ghat during the restricted hours. To minimise inconvenience to the public, essential services and smaller vehicles have been exempted from the ban. These include KSRTC and other public transport services, cars, jeeps, taxis, ambulances, emergency medical vehicles, fire and rescue services, civil defence and disaster response vehicles, armed forces, central paramilitary forces, police vehicles, and vehicles granted special written permission by the district collector or other competent authorities. As part of the enforcement measures, cops will be deployed round the clock at Adivaram on the Kozhikode side and Lakkidi on the Wayanad side of the ghat road, in coordination with the Wayanad police. The collector warned that vehicle owners and drivers violating the order would face strict action under Section 51 of the Disaster Management Act, 2005, as well as relevant provisions of the Motor Vehicles Act, 1988. The forest department has also been instructed to urgently remove trees that pose a danger in landslide-prone stretches of the ghat road, while the NH wing of the public works department has been directed to closely monitor the condition of the road during the monsoon period.

415 NDPS cases registered

LAW ENFORCEMENT agencies have intensified their fight against narcotics trafficking and drug abuse in 2026, registering a total of 415 cases under the Narcotic Drugs and Psychotropic Substances (NDPS) Act and arresting 513 accused people during the year in Kozhikode district. According to official figures, the cases included 21 commercial quantity cases, nine medium quantity cases, 23 small quantity cases and 340 cases related to personal consumption. During the crackdown, authorities seized 2.655 kg of MDMA, 51.475 kg of ganja, two ganja plants, 9.9g of methamphetamine and 16.91 g of brown sugar.

Raid on Labour Contract Society

THE CRIME Branch has conducted a detailed inspection at the Park Road office of the Kadathanad Labour Contract Cooperative Society in Vadakara as part of its investigation into the death of an elderly depositor, Ibrahim Haji, who died after attempting suicide outside the residence of a Congress leader. The investigation focuses on the circumstances surrounding Ibrahim Haji's death as well as the society's financial dealings. The inspection comes amid mounting complaints against the cooperative society from depositors and members of the public. During the raid, Crime Branch officials seized several documents, including office ledgers, vouchers, day books, cash books, work registers, fixed deposit bonds, cheque issue registers, contract-related files, and other financial records. Following the inspection, the society's office was sealed by the Crime Branch. Authorities have confirmed that all cases connected to Ibrahim Haji's death will now be investigated by the Kozhikode Rural District Crime Branch. These include the case related to his death, a separate case involving the alleged loss of Rs 22 lakh deposited in the cooperative society, and another case registered based on a complaint filed by the cooperative department. Allegations have been raised against four individuals, including DCC secretary Sudheer Kumar.
