

Stress test for truce as Iran, US exchange strikes

Bahrain, Kuwait intercept incoming missiles; Tehran says US endangers regional security, lacks will for stability

CAIRO
IRAN fired ballistic missiles and drones toward Bahrain and Kuwait early on Saturday, Bahrain's government said, adding that they were intercepted. It called on Tehran to immediately cease attacks on Gulf neighbors that it deemed a "serious escalation."

Iran's foreign ministry said the US early on Saturday attacked surveillance facilities on Qeshm Island and near Sirik that it said were used to protect borders and "ensure the security of navigation in international waters." Tehran called the attack a violation of the fragile ceasefire.

3 Lebanese soldiers killed in Israeli attack

AN Israeli strike on a vehicle in southern Lebanon killed three soldiers, Beirut's military said on Saturday, days after the countries agreed a conditional truce during talks in the United States.

The latest exchange of fire came as the Trump administration pressed Iran to make a deal to end the war that has strained the global economy and threatened a hunger crisis in some of the world's most vulnerable countries.

Israel has launched an operation into Lebanon to root out the Tehran-backed armed group Hezbollah, which dragged Lebanon into the wider West Asia war by launching missiles on behalf of its sponsor.

The US military earlier said it shot down several Iranian missiles and drones launched toward the Strait of Hormuz and Gulf Arab allies, and struck some of the Islamic Republic's coastal surveillance radar sites in response.

Lebanon has vowed that it will disarm Hezbollah over time, but has also denounced Israel's invasion, accusing it of employing scorched earth tactics to drive civilians out of towns and villages. In the latest incident, the Lebanese army said, two officers and a soldier were killed in a strike.
